I submit herewith my visit remarks on the application
for the above institution for the grant of affiliation by
the Central Board of Secondary Education, New Delhi as follows.

I visited the Sri Sathya Sai Vidya Vihar, Muvvulnavnipalem of Visakhapatnam on 28.7.1986. This was founded by a Society by Name "Bhagavan Sri Sathya Sai Vidya Vihar Educational Society", Visakhapatnam during 1984. This was registered under Act. XXI of 1960 on 20.6.1984 with registration No. 221. Photostat copies of the Memorandum of Association and rules and regulations are enclosed.

The Society passed a resolution on 1.6.86 to dissolve the society and to handover the property of the School to Sri Sathya Sai State Unit A.P. The State unit has yet to take over the Institution.

FINANCIAL:- The School building is constructed at a cost of 31 Lakhs in an area of 1.87 acres in Muvvulnavnipalem. There are 32 rooms in the building. There are also three quarters for the teaching staff, a Prayer Hall and a service Centre (Hospital). It has a fixed deposit of Rs. 1,00,000/- in the Vysay Bank Limited deposited on 21.6.85 for five years (No. 3G0580/143/85). The financial position is quite sound.

ACCOMMODATION:- Quite adequate and suitable. All rooms are electrified with tube-lights and fans are fixed.

FURNITURE:- Is quite adequate. It is worth more than a lakh.

EQUIPMENT:- Is adequate, it is worth nearly Rs.70,000/-

LIBRARY :- About 367 Books are purchased at a cost of Rs.3510/-. There are about 600 books donated by Public.

CLASSES:- The School is now having Classes from L.K.G. to VIII Standard. The strength is 780 as on to-date vide statement enclosed. They are not presented to any Examinations.

STAFF:- There are 31 teachers including the Principal. 10 are trained and the rest are un-trained. Out of the un-trained teachers, most of them are Post-Graduates. The un-trained teachers may have to be replaced by trained teachers when affiliation is granted.

SALARIES The Principal is paid Rs.1000/Rs.1100/- The trained teachers and Post Graduates are given Rs.750/- and the rest are paid Rs.500/- (Consolidated) per month. When affiliation is granted the teachers have to be paid either State Government Scales of Pay or the Central Govt. Scale of Pay.

TUITION FEE:- Fees are collected at Rs.40/-per month for L.K.G. and U.K.G Students and at Rs.30/-per month for other classes for 12 months besides special fee of Rs.30/-per month for 12 months are collected for all classes. Admission fee at the time of admission is Rs.100/- per student, Caution deposit of Rs.100/-per student is collected and it is refundable when the student leaves the School. Rs.5/-per month for 12 months is also collected as Science fee from Classes VI and VII Students.

SYLLABUS:- Central Board of Secondary Education syllabus is followed.

TIME:- The School is run from 8.00 A.M. to 1.30 P.M. with an interval of 10 minutes in the middle.

PLAY AREA:- is about 1,500 Square Yards.

ACADEMIC SESSION:- The academic session is from June to April.

POSSIBILITY FOR EXTENSION:- There is ample scope for extension of the School up to Higher Secondary Level.

MEDIUM OF INSTRUCTION:- is English, Hindi and Sanskrit are also taught.

AGREEMENTS:-

There are no agreements between the teachers and the Management. They are appointed temporarily. Those who have completed one year are confirmed. No Service Registers are maintained. There is no scheme of provident Fund and Gratuity.

In the above circumstances, I recommend Sri Satyendra Vidya Vihar, Muvvalavanipalem of Visakhapatnam may be recommended for affiliation to the Central Board of Secondary Education, New Delhi duly signing the 'No Objection Certificate' at an early date. The original application along with the proposals are enclosed herewith.
